

- 1. A Photocopy of the identification card of the applicant which identify him/her
- 2. Where an application is signed by an agent guardian, a photocopy of a power of attorney / guardianship
- 3. Two recent passport sixed photographs of the applicant/manager/guardian
- 4. Where the applicant is previously registered at the regional level , a photocopy of the principal registration

- Where the commercial company is registered at the regional level, a photocopy of its articles and memorandum of association as well as certificate of the principal registration shall be submitted
- Competency certificate from concerned sector organization
  - Unless the business license is renewed within four months after the expiry of the budget year in which the license has been issued or renewed upon payment of the appropriate fee, the business license shall not, in any way be put in use.
  - After the Expiry of the time for renewal of business license without penalty provided for under sub article(2) of this article, the business licenses shall be renewed without penalty in the following months of Hidar and Tahisas.
  - The holder of a business license who has failed to have it renewed within the time specified under sub article (2) (3) of this Article, shall have it renewed within the time, from Tir 1 to Sene 30 by paying in addition to the renewal fee, a penalty in

Birr 2,500(two thousand five hundred), for the next each month of delay.
